



### **Assumption of Risk**

In consideration of participating in gymnastics and/or dance activities and/or fencing, I represent that I understand the nature of this activity and that I or any minors I enroll are qualified, in good health, and in proper physical condition to participate in such activity. I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue participation in the activity.

I fully understand that this activity involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, or inactions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the releasees named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, cost, and damages I incur as a result of my participation in the activity.

### **Release of Liability**

I hereby release, discharge and covenant not to sue PB&J, LLC, Northpointe Gymnastics and Northpointe Fencing, its respective administrators, directors, agents officers, volunteers and employees, other participants, any sponsors, advertisers and, if applicable, owners and lessors of premises on which the Activity takes place (each considered one of the "RELEASEES" herein) from all liability, claims, demands, losses or damages on my account caused or alleged to be caused in whole or in part by the negligence of the "Releasees" or otherwise, including negligent rescue operations and future agree that if, despite this release, waiver of liability and assumption of risk I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save and hold harmless each of the Releasees from any loss, liability, damage or cost, which may occur as the result of such a claim.

### **Payment Policies**

Automated payments using a credit card or ACH is the required method of payment. Input of Credit Card or ACH Information signifies acceptance of the PB&J LLC, Northpointe Gymnastics and Northpointe Fencing autopay program. Input of Credit Card or ACH Information also signifies acceptance of our drop policy. Drop Policy: Notice must be in writing or email to the PB&J LLC, Northpointe Gymnastics and Northpointe Fencing office on or before the 15th of the month prior to the upcoming session to drop a class and to discontinue billing and autopay. Autopay is run every four weeks, (on the 20th for recreational gym and fencing and dance classes, and on the 1st for team classes.) Annual Registration Fees apply. \$35 for the first registration, \$28 for the 2nd registration, \$21 for the 3rd and following registrations. Annual registration fees will run with autopay each year on the anniversary of enrollment.

### **Medical Emergencies**

I, the parent or legal guardian of the below indicated minor(s), fully understand that PB&J LLC, Northpointe Gymnastics and Northpointe Fencing staff are not physicians or medical practitioners of any kind. With the foregoing in mind and in the event that any kind of injury or illness should occur to my child while on PB&J LLC, Northpointe Gymnastics and Northpointe Fencing premises, I hereby authorize PB&J LLC, Northpointe Gymnastics and Northpointe Fencing to render first aid as deemed necessary in their discretion and/or to seek medical assistance, including calling 911 or otherwise arranging for the transport of my child to an appropriate facility for treatment. Additionally, I hereby authorize any trained and licensed medical professional to administer emergency medical treatment to my child should injury or illness occur in my absence. I understand that PB&J LLC, Northpointe Gymnastics and Northpointe Fencing will make every effort to promptly notify me of any such emergency.

### **Photo and Video Release**

I hereby authorize PB&J LLC, VEGA North, Northpointe Gymnastics and Northpointe Fencing to use photographs or video taken of my child while participating in PB&J LLC, Northpointe Gymnastics and Northpointe Fencing classes and/or activities in their marketing and training materials as well as on their websites. I understand that if my child participates in the Annual showcase or fencing or gymnastics meets that the performance will be videotaped and could possibly be broadcast on local television.
